Registering your vehicle online for an AACA National

*Go to: AACA site, www.aaca.org;

*Click on: Event Registration;

*Enter your member number and pin number from your AACA Member card and click submit;

*Click on Meet Pre-Registration;

*Click on August 11-13 Central Fall Nationals;

*Click on #1. Your previously entered vehicle list will come up. If the vehicle you want to register is not shown, then click on "Add Vehicle";

*Determine your class by going to the bottom and clicking on: Not sure what Judging Class your vehicle is in? Click Here. 'Official Judging Guidelines' will come up. Scroll down to Section 4. There are two "certified", non-points judged Classes: HPOF and DPC. Many of you who have vehicles that are not restored or who do not want point-judged may choose one of these classes;

Note: The objective of AACA judging is to evaluate an antique vehicle, which has been restored to the same state as the dealer could have prepared the vehicle for delivery to the customer. This includes any feature, option or accessory shown in the original factory catalog, parts book, sales literature, or company directives for the model year of the vehicle. Point-judged vehicles are classes 1A – 38 restored vehicles or near perfect original.

*Click on 01A to reveal all classes including HPOF and DPC;

*Scroll down and click on your class. Enter your vehicle information and Save.

*Next your vehicle list will come up. Add additional vehicles to be entered then click on 'Register' and 'Yes'. Click on 'Register again' if adding more vehicles. Finish registering additional vehicles and review your current list of events.

*Click 'Print Cards'. Note: Registration cost for this event be will one of the lowest ever.

*. Click one of these options: Don't print my receipt yet if you have (an) additional vehicle(s); or if you are finished, click Print your receipt and follow mail-in instructions.

Note: If you are registering (a) vehicle(s) for this event, payment is to go to Mary. You can mail or give it to her at an event. If there are any changes after printing your cards, she will be your contact.

Show Time we will be loading in entered vehicles on both Friday and Saturday morning. We would like to have members' cars in after the field is laid out Friday to help set others up at the proper display angle.



CENTRAL FALL NATIONALS MEET COMMITTEE MEETING MARCH 16, 2022

Gary Gleason reported that the meet income and expenses right now are at a net \$-185.56, but ad income will hopefully come in soon to change that.

Program Cover choices –Annette presented two cover choices for the meet book that were shared and discussed. The group voted for view #1. Annette will not be able to do artwork or editing on the meet book. Editor rates are approx.. \$80/hour. Mark has 2 company quotes pending to do this work.

Program Review – Mark reviewed the articles we agreed should be in the meet book. Fred said his local car article will be 4 pages. Mary will handle the welcome letters. Other items are maps, show/event schedule, tour information, history of IH (Sandy). All articles due by April 15th.

QC Tour Route – Clair presented the QC Tour routes, times, etc. The tour will leave at 1:00 p.m. and return by 5 p.m. for dessert. Suggestion made to have truck/trailer for any breakdowns. Clair will see if the Deere Headquarters will be open. The tour was approved by the committee.

Sponsorships – the list of sponsors was reviewed and additional potential sponsors added. Names were put with sponsors to follow up and seek ads for the meet book.

Golf carts – Mark gave us prices and sizes of available golf carts. It was decided to get 2 minimum and 4 is possible. Cambridge has electric carts for \$850/4 days.

Clair will get two way radios from Snowstar at no charge for use during the meet.

John gave prices for rolls of plastic to be placed under the cars. Fred located a source for 3' wide plastic that will be explored. John has approval to order the mirror hang tags 1,000 for \$49.

Grand National Meet was approved by the MVR Board and is scheduled to be held **August 10-12**, **2023.** Discussion involved potential location for the Grand National as the daily cost for the XPO center will be \$4,000/day. The Zenith car judging must be indoors and could involve a 3rd day of cost. Two other sites discussed were downtown Davenport and the Bettendorf Convention Center. Issues were street congestion and security in Davenport and lack of adequate trailer parking at Bettendorf site. Our recommendation is to host this at the XPO Center and try to negotiate the rates and the schedule for the meet. This will be presented to the Board at the April meeting for a vote.

It is commonly known that many model-t's were equipped with tracks and skis to operate in snowy environments. The first snowmobiles. Many rural postal carriers used them. As their oath says:

Another innovative use was by the railroads. Section gangs were a group of men that was responsible for the maintenance of a "section" of the rail line. This image evoked memories of my family members that worked for the CB&Q Railroad, now the Burlington Northern Santa Fe. This would have been much easier and faster transportation than the old manually operated hand car.
