

2022 Fall Show Venue

Last month, members of the MVR were invited to tour the proposed venues for the 2022 Fall Meet. The Bend in East Moline is a new development consisting of a concert venue, a banquet hall, restaurants, a brewery, a Hyatt hotel and a 64,000 square feet, event center.

The Hyatt Place - Hyatt House is actually two hotels in one. Located just steps away from the event center, it is an excellent choice for the show hotel. The Hyatt offers a made-to-order breakfast, lunch & dinner restaurant, a 9th floor lounge with extraordinary views of the Mississippi River, a guest patio with a grille, access to the bike path along with rental bikes, a business center, meeting room for up to 80 people, aquatic pool and 24-hour exercise facility.

The BEND XPO is a brand new (not yet open), state-of -the-art exposition hall featuring LED lighting, 2 banks of restrooms, a concessions operation and meeting rooms for judging schools, etc. This facility was designed with automobile use in mind as MECUM Auctions has signed a long-term lease to use the facility for their Quad Cities-based tractor auction venue.
