

## **CAR CORRAL 2022 CENTRAL FALL NATIONALS**

Registration deadline for the Car Corral is Wednesday, July 20<sup>th</sup>, 2022.

All Fall Meet vendors must be a member of the National AACA in good standing for the current show year. To join call Mary Bartemeyer, 563/340-3266. Half year membership also available for non AACA members.

Registration for Car Corral space(s) can be attained by logging on to [www.aaca.org](http://www.aaca.org) and click on Event Registration. Enter your member # and pin #, Meet Pre-registration on next screen, choose Central Fall Nationals, then item #3, "Register" "Car Corral Space", complete and submit. Set up for the car corral is Friday, August 12<sup>th</sup> from 8am to 10am in the north parking lot directly across from the main entrance to the XPO show field building. The car corral will be open 10am-4pm Friday and 8am to 3pm Saturday the 13<sup>th</sup>.

The following paragraphs are only part of the AACA regulations. You must read the full AACA Policies and Procedures regulations. Strict adherence will be followed. Visit [www.aaca.org](http://www.aaca.org) and click on P&P manual, then Chapter 5.9 and pages 100 through 103. The AACA considers the Car Corral and Flea Market (swap meet) regulations to be one and the same.

### **Car Corral Regulations highlights**

1. \$35.00 per space (approximately 10' x 20'). One (1) vehicle per space.
2. Vehicles must be 25 years old or older (latest being 1996 model year).
3. Must be AACA show field eligible: no street rods, modified, custom or replicars. Please include as much info as possible on any vehicle you feel may be questioned.

4. All vehicles must be driven into the car corral. All vehicles brought on trailers will unload on north end of same parking lot. No vehicles are permitted to remain on trailers to show and no swap meet items are permitted in the car corral.
5. No space is transferable to anyone else.
6. Any canopies must be anchored securely and appropriately for the concrete surface.
7. Alcoholic beverage consumption on the premises is prohibited.
8. Political signs, political memorabilia, bumper stickers, pins, buttons, etc. are not permitted at any National Meet.
9. All transactions are between buyer and seller.
10. Since the Nationals are open to the general public, the meet host has the right to expel, either immediately or after suitable warning, any person(s) including car corral vendors who conduct themselves in a way that would reflect unfavorably upon the AACA or fail to abide by any regulation as per 5.9.1 and 5.9.4 of the regulations. This could include possible withdrawal of future car corral privileges and AACA membership. No refunds of space leasing price will be made in the event of expulsion. Any expenses involved in removing of the vehicle from the car corral area must be borne by the person(s) being expelled.
11. Final decisions are made by the Fall Meet Chairman.

**Additionally**

1. Car corral spaces will be assigned by number and the numbers will be marked on the pavement. Requests for adjoining spaces by vendor showing more than one vehicle will be honored to the extent possible.
2. All vehicles are to be removed by the end of the meet activities Saturday and space left clean.
3. Any returned check will be charged same as bank charge.
4. Neither the Mississippi Valley Region nor the owners of the property will be responsible for damaged or stolen vehicles or any part thereof.
5. Ample bathroom facilities are available close by just inside the XPO building.
