Golf carts – three are needed: 1 for Alan Ford, 2 for trailer parking.


Mark will check on details RE the ice cream social: who is serving? What about all supplies?

Gathering at U-Haul on a very windy day, we made our way to the museum on Highway 6. We blew into the place and were greeted by the staff. We had 20 members in attendance, and everyone was on their own to tour the expanded museum with some recently acquired trucks from the last Mecum Auction at The Bend. One of their recent acquisitions was a 1920 MacDonald 7 <sup>1</sup>/<sub>2</sub> ton lowbed stake truck. This highly mechanical truck is front wheel drive, has power steering and features hydraulic brakes a year before Duesenberg! Their newly expanded museum space allows more trucks to be on display like the Velie and the Independent that were both locally made.

We headed to eat in the banquet room at I-80 and ordered off the menu or hit the buffet. Mary gave some updates on club events, including signup times for members who wish to enter vehicles in the Central Fall Nationals meet. # Dodge puts a stop to Stutz


Problem: Someone with a 27 Stutz needed to add hydraulic brakes to their front axle.

For a year and a half Stutz featured "hydrostatic brakes". The master cylinder comprised a large cylinder area with a compressible bladder. Out on the wheels were 6 segmented brakes with a flexible bladder similar to a bicycle inner tube. When pedal was depressed the water/alcohol mix was displaced by the master and flowed thru lines to the wheel bladders. As they expanded the shoes would equally apply braking pressure. Well, it is a great system if it not for the issue with the bladder material not lasting. Most owners adapt some sort of hydraulic system to the rear and try to get by. They can add later model Stutz hydraulic brakes all around but parts are not available on these ultra-rare vehicles.

Some previous mechanic had added hydraulic brakes to the rear and it appeared to function well operated by an added master cylinder under the floorboards. In consulting with Stutz experts some had Chrysler backing plates that would require cutting out the middle and cutting out the outer from the Stutz backing plate and trying to align and weld back together. I have a lot of 45-68 Dodge Power Wagon 1 ton parts and after some measuring it looked like the best solution. After machining an adapter plate to locate the ID of the Dodge plate to the ID of the Stutz spindle and spacing ¼" outward the assembly was drilled for the Stutz spindle pattern. This setup allowed for use of the original Stutz hub and brake drum. All new replacement parts were acquired from Vintage Power Wagons in Fairfield Iowa.
