MINUTES OF MISSISSIPPI VALLEY REGION BUSINESS MEETING

NOVEMBER 16, 2019 DURING FALL BANQUET – ROCK ISLAND, IL

Mary Bartemeyer, President, called the meeting to order following the banquet meal.

John Brewer reviewed the By-Law changes made by the Board in recent meetings with everyone having a copy to see. After all changes were explained, a motion to accept was made and seconded with unanimous approval.

Discussion followed on possible activities for 2020 including day trips, overnight weekend trips using a van we can rent for \$275 for 2 days, etc. Suggestions were given as to different ideas/places we could go as a group or individually in our cars.

Other car club calendars will be reviewed to see where collaboration could happen that would benefit all clubs involved.

Mary reported that LaVonne Gleason has resigned as club secretary and requested a volunteer who would be able to attend monthly meetings and take minutes for publication in the newsletter. No volunteers were noted during the meeting. This position needs to be filled by January 8th.

The meeting was adjourned in order to continue voting on silent auction items. The new trifold was passed out for members to distribute during future events.
